

## **San Antonio Figure Skating Club Guest Coach Policy**

This Policy does not pertain to coaches coming in for special events such as: test sessions, competitions, exhibitions, or any other type of event of this nature.

Guest Coaches wishing to teach on San Antonio Figure Skating Club (“SAFSC”) ice sessions may do so after signing a San Antonio Figure Skating Club Guest Coach Agreement with the San Antonio Figure Skating Club.

1. Guest coach must appear on the United States Figure Skating’s Coach Registration list AND must have an all “green” status.
2. Guest coach must provide copies of current USFSA membership card and liability insurance which will be kept on file by SAFSC for the current skating season.
3. Guest coach must adhere to all SAFSC ice policies and procedures (current SAFSC ice rules can be found at <https://www.safsc.org/ice>).
4. Guest coach must check in with the SAFSC ice monitor and
5. SAFSC reserves the right to remove guest coach from club ice and suspend guest coach privileges for failure to comply with any SAFSC policies and procedures.

## Terms and Conditions:

I am a current member in good standing with U.S. Figure Skating (USFS).

1. I agree to familiarize myself with SAFSC ice rules, and to abide by them. All rules and policies of SAFSC are available on our website, <https://www.safsc.org/ice>.
2. I have purchased a liability insurance policy with amounts recommended by U.S. Figure Skating.
3. I abide by the USFS Code of Ethics.
4. I understand that solicitation of any kind will not be tolerated in the skating facility.
5. This agreement is valid for the current skating year ending on June 30.
6. This agreement may be terminated at any time at the sole discretion of the SAFSC Board of Directors.
7. I will email this completed Guest Coach Agreement along with a copy of my liability insurance and USFS credentials to [skate@safsc.org](mailto:skate@safsc.org) at least one week prior to my first day of guest coaching.

I hereby agree to the above Terms and Conditions as a condition of being granted guest coach privileges by SAFSC. I understand that any violation of the above terms, or any rule, regulation or policy of USFSA or SAFSC may result in a loss of my privileges.

## Assumption of Risk and Waiver of Liability:

I am aware that figure skating is a dangerous sport, and that my participation as a guest coach with SAFSC is at my sole risk. I hereby agree to release, indemnify and hold harmless SAFSC, and all of their directors, officers, agents, insurers, attorneys and employees from any and all claims, demands, losses, damages or injury, whatsoever, of any kind or nature, that I may sustain as a result of my participation or activities as a guest coach of SAFSC.
