



SAFSC Competition Team Policy

All San Antonio Figure Skating Club (“SAFSC”) Full Members and Introductory Full Members, without regard to testing or competition level, are eligible to apply for SAFSC Competition Team Status (the “**Competition Team**”). Qualification for the Competition Team is driven by a Point Allocation System and satisfying the Eligibility Criteria listed below. Competition Team Members will be announced at the SAFSC End of Year Banquet.

Eligibility

- A. Member must be a Full Member or Introductory Full Member of the San Antonio Figure Skating Club;
- B. Member must be in good standing with the San Antonio Figure Skating Club and U.S. Figure Skating;
- C. Member must have competed as a Member of the San Antonio Figure Skating Club;
- D. Member must satisfy the point qualification threshold and requirements set forth herein; and
- E. Member must complete and submit the online SAFSC Competition Team Application no later than June 1, 2025;
- F. All competitions must be completed between June 1, 2024 and May 31, 2025. Member must have represented SAFSC at all competitions;

Point Allocation System

To qualify for the Competition Team during the current skating year (July 1, 2024 - June 30, 2025), the eligible Member must accrue a total of four (4) points based on the Point Allocation System.

Only USFS Sanctioned Competitions will be counted in the point calculation for each Member. Participation in Fall Fest, Skate into Spring, Learn to Skate exhibitions and competitions or other local rink hosted competitions and exhibitions will not be counted in the point calculation. Alamo Skate is a sanctioned competition and will be included in the point tally.

Medical Bye in case of competition withdrawal for medical reasons: a skater may request a medical bye from the SAFSC Board of Directors in place of one (1) competition point to earn placement on the Competition Team. The following terms apply:

- A. The Medical Bye may only be used once during the skater’s membership with SAFSC.
- B. It may only be used for placement on the Competition Team, no other award.
- C. The skater must have been registered for the competition with plans in place to attend.
- D. The medical emergency preventing the skater from competing must have occurred within the two (2) weeks prior to the competition date.



- E. The skater must submit a note from their doctor and coach with their competition team application. The doctor's note can be a receipt of attendance or a note similar to a school note stating the return to skating date. The skater's coach must confirm legitimacy

The SAFSC Board of Directors will have the sole authority to approve or reject a submitted application and will notify the applying Member of such acceptance or rejection.
